

Terms and Conditions

of the "Bonus for a Consent" Special Offer

valid from 9 April 2020 until discontinued as last amended on 14 October 2023 PREP/PDF01/0420

"Bonus for a Consent" (hereinafter: "Special Offer") is available to Subscribers of an Orange pay as you go plan.

- 1. By taking advantage of the Special Offer, the Subscriber may receive a bonus package of 200 GB to be used in Poland (hereinafter "Bonus") for giving a marketing consent as per these Terms and Conditions.
- 2. The Bonus shall be valid for 31 days from the date when it is granted, which will be notified to the Subscriber via a text message.
- 3. The Bonus will be automatically credited to Subscribers who text **TAK** to the free number **80290** while the Special Offer remains valid and meet the conditions described further below. By sending the text message, the Subscriber gives their consent ("Consent") to receive commercial information by electronic means.
- 4. To be eligible for the Bonus, the Subscriber must have a valid Main Account when giving the Consent.
- 5. The Bonus shall be credited within 24 hours. The Subscriber will be texted a confirmation of giving their Consent and a Bonus award notice.
- 6. Bonus credits shall be consumed before those from other data packages and before Main Account credits.
- 7. The Bonus status and credit balance can be checked by:
 - a. logging in to Mój Orange; or
 - b. texting "ILE" to the number 411 (Orange texting charge applies) for users of the Orange Free pay as you go and Always Unlimited plans; or
 - c. texting "ILE DANYCH" to the number 901 (Orange texting charge applies) for users of the Orange IoT pay as you go plan.
- 8. A Bonus may be granted only once after the first effective Consent in the history of the Subscriber's number is given via a text message.
- 9. A Subscriber who has already given a Consent once via a text message before 16 October 2023 shall not be eligible for the Bonus.
- 10. Giving Consent by other means than texting 'YES' to 80290 shall not entitle the Subscriber to receive the Bonus.
- 11. These Terms and Conditions are available at the Operator's seat, at www.orange.pl, in Orange stores and Orange partner stores. Matters not regulated by these Terms and Conditions shall be governed by the telecommunications service terms and conditions for pay-as-you-go Subscribers.
- 12. Giving Consent is voluntary, but failure to give it shall preclude the Subscriber from benefiting from the Special Offer. Participants in the Special Offer have the right to view their consents and withdraw them at any time by using any contact channel made available by the Operator, in particular by logging in to their individual account at www.orange.pl or in the Mój Orange application, by calling the Customer Service Office (charge as per the Subscriber's tariff) and in any Orange store. The withdrawal of consents is free of charge.
